VACCINATIONS: Every owner of a dog 4 months or more of age shall cause such dog to be vaccinated against rabies by a veterinarian at such intervals as required by law. See front side of certificate for revaccination due date. With questions regarding dates or fees call 734-8538.

REGISTRATION: Every owner of a dog 4 months or more of age shall register such dog with the Treasurer of Warren County. Registration is required within 30 days following previous year's vaccination and ANNUALLY. Fees Are Within:

Vaccination date - 30 days - \$10.00; 31-90 days - \$20.00; 91-180 days - \$25.00; 181-365 days - \$30.00

NON-ALTERED DOGS: Effective January 1, 2008, any new dog that is not spayed or neutered by the second year registration date will be assessed an annual fee of \$45.00.

The Treasurer will then issue the registered vaccination tag.

KENNELS: Shall be registered annually prior to July 1, of each year or within 30 days of establishment of said kennel with all kennels to be approved by the Administrator.
